- the potential to be a destiny changer in his or her chosen field.
- → There is no age limit, but preference will be given to candidates under the age of 35.
- → Candidates who are currently, or have been studying overseas, will not be considered for this scholarship.
- → Successful candidates are required to return to South Africa for at least five years after completing their studies.
- → What makes this scholarship different from most is not only the personal interest which Laurie Dippenaar, chairman of FirstRand, takes in the selection process, but also his interest in the ongoing progress of the recipients.
