The Cape Leopard Trust (CLT) is seeking a suitably qualified Conservation Director to lead and drive its research and conservation efforts and develop its long-term strategy.

The Cape Leopard Trust's purpose and vision is to ensure the long-term survival of leopards, their habitat and their prey, for the benefit of nature and society. We do this through rigorous scientific research, applied conservation initiatives, environmental outreach and education, in collaboration with communities, private landowners and organisations.

Job Summary:

Reporting directly to the CEO, the Conservation Director is responsible for leading, administering, planning, designing and managing all research and conservation initiatives across the organisation.

Travel required: CLT project sites and other areas in the Western Cape

Key Responsibilities:

- Lead the design and delivery of the conservation goals and objectives of the CLT;
- Structure regional predator research in partnership with local and international stakeholders and CLT Scientific Advisory Board;
- Create initiatives to strengthen biodiversity and leopard conservation;
- Identify new collaborative opportunities for reducing key threats.
- Advance community-driven stewardship agreements to protect leopards and mountain ecosystems;
- Contribute to fundraising, donor recruitment and relationship maintenance;
- Promote CLT's work in public venues, through organising/attending conferences and workshops;
- Collaborate with the Environmental Education & Outreach Manager to create appropriate projects;
- Write grant proposals and funding applications.

Essential Requirements:

- A higher degree (PhD) in wildlife ecology, carnivore conservation, or another field relevant to the position's responsibilities.
- At least five years of experience working in a conservation management or policy position.

- Experience in large multi-faceted project or program management, personnel management, administration, and fundraising.
- Familiar with the academic research landscape and leveraging collaboration opportunities.
- Knowledge of conservation biology, practical conservation, and African conservation issues.
- A five-year publication track record.
- Excellent communication and organisational skills.
- Excellent, fluent spoken and written English, understanding of Afrikaans and Xhosa an advantage.
- Private medical care compulsory.
