# POST-DOCTORAL RESEARCH FELLOW X2 POSITIONS

The Health Economics and HIV and AIDS Research Division (HEARD), UKZN, South Africa is recruiting 2 post-doctoral researchers to work on joint research projects with the Centre de Recherches Sociologiques et Politiques de Paris (CRESPPA), France.

These projects bring together expertise and networks of two recognised international research centres. **HEARD** is an interdisciplinary social science research institute based at the University of KwaZulu-Natal and has extensive experience in conducting applied research amongst vulnerable populations in East and Southern Africa with a particular focus on sexual and reproductive health and rights. **CRESPPA**, affiliated to the Université Paris 8, Nanterre University and the CNRS. is one of the major social science research centres in France and has a long history of leading the research agenda on issues of gender equality. The successful applicants will be expected to engage in **1-year training fellowships** under the supervision of mentors and the Principal Investigators of the research project.

# **POSITION 1**

# **POST-DOCTORAL RESEARCHER (AWASA Project)**

Type: One (1) Year Fixed Term Post-Doctoral Scholarship (Renewal subject to performance & funding availability)

Location: University of KwaZulu-Natal, Durban, South Africa

The Health Economics and HIV and Aids Research Division (HEARD) and the Centre for Sociological and Political Research (CRESPPA) have recently launched a 4-year joint research programme titled: Advancing women's access to safe abortion through coalition building and strengthening strategic advocacy in sub-Saharan Africa (AWASA).

The AWASA research project, funded by the French National Centre for Scientific Research (CNRS), aims to foster normative change by building linkages and capacities and creating real coalitions involving researchers, civil society, decision makers and journalists to advocate strategically on Termination of Pregnancy (TOP) law reform, development of comprehensive abortion care policy and

implementation of existing related policy to the fullest extent of the law. It is intended that the results of the project have a direct impact on the effectiveness of advocacy and related activities to promote and ensure access to safe abortion in each of our target countries to the fullest extent of the law. Specifically, the research will build coalitions of actors working to ensure access to safe abortion; build capacities of civil society to locate good scientific evidence and transform this into advocacy tools; build the capacity of journalists to report on abortion using evidence-based information; and build local and regional networks of parliamentarians and other decision makers who can work together to advocate for access to safe abortion across the regions.

The project includes Anglophone and Francophone research partners and will be carried out in Côte d'Ivoire, Madagascar, Malawi, Republic of Tanzania, Senegal, and Zambia. The successful candidate will have opportunity to travel between France and South Africa and to different study countries where annual workshops will be held.

- A doctoral degree in a relevant social sciences discipline obtained in the past five (5) years, with a strong background in sexual and reproductive health and rights and/or gender studies
- Strong interest in intersectional feminist analysis and gender studies.
- Strong analytical and writing skills in English, demonstrated through peer-reviewed journal articles. Fluency in French would be an advantage.
- Strong presentation skills, demonstrated through presentation of papers at conferences.
- Keen to work collaboratively with other academics, NGO's, students and target group organisations.
- Ability to develop networks and to engage with a range of stakeholders.
- Be based at HEARD for the duration of the scholarship.
- All candidates from Sub-Saharan Africa will be considered but preference will be given to suitably qualified South African citizens or permanent residents.

### **POSITION 2**

### POST-DOCTORAL RESEARCHER (Research on SRHR and GBV in the Context of Migration)

Type: One (1) Year Fixed Term Post-Doctoral Scholarship (Renewal subject to performance & funding availability)

Location: University of KwaZulu-Natal, Durban, South Africa

HEARD and CRESPPA have been engaged in collaborative research on women migrants and refugees in South Africa, with a focus on sexual and gender-based violence in the context of migration and the SRHR of women migrants and refugees. This research will be pursued through an European Union funded project on young refugees, and another joint project on SGBV against migrant and refugee women.

These projects will bring together academic researchers, members of civil society organisations working with migrants and refugees, and policy makers in order to produce new data and knowledge on the intersectional vulnerabilities of young refugees, on SGBV in the context of migration, and on the SRHR of migrant and refugee women. Research will be used to design improved policy and programmatic frameworks which will have a gender transformative impact on migrant and refugee women, reducing vulnerabilities to SGBV and improving access to SRHR services including services for survivors of SGBV.

All research will be carried out within a feminist intersectional framework and will employ participatory research methods with women migrants and refugees.

The projects will be implemented in South Africa as well as in other countries including France, UK, Greece and Canada. The post-doctoral candidate will carry out research in South Africa and will have the chance to travel to other project countries for collaborative workshops and conferences.

- A doctoral degree in a relevant social sciences discipline obtained in the past five (5) years, with a strong background in migration/forced migration, and/or gender studies.
- Strong interest in intersectional feminist analysis and gender studies.
- Strong interest in participatory research methods.
- Strong analytical and writing skills in English, demonstrated through peer-reviewed journal articles.
- Fluency in another language (particularly Swahili or Lingala) will be an advantage.
- Strong presentation skills, demonstrated through presentation of papers at conferences.
- Keen to work collaboratively with other academics, NGO's, students and target group organisations.
- Ability to develop networks and to engage with a range of stakeholders.
- Be based at HEARD for the duration of the scholarship.
- All candidates from Sub-Saharan Africa will be considered but preference will be given to suitably qualified South African citizens or permanent residents.
