The successful individual will be responsible for the overall nursing management of clinical trial participants at the UKZN Clinical Trials Unit.

Minimum Requirements

- Bachelor's degree in Nursing and Midwifery
- Current Registration with South African Nursing Council (as a Professional Nurse)
- 3 years clinical trial experience

Knowledge and Skills Required for the Post:

- Experience with recruitment of clinical trial participants including obtaining informed consent
- Perform clinical procedures as per study protocol
- Experience in study drug administration
- Experience with collection of biological samples for laboratory investigations

Key responsibilities:

- Meet with clinic managers to brief them of the study and establish recruitment processes.
- Screening of potential participants for eligibility as per protocol
- Discuss study details with potential participants and assess participant understanding.
- Conduct informed consent process with participants
- Assess vitals at every visit
- Conduct physical examination as per protocol
- Arrange for ECG, X-RAYS etc with external service providers.
- Administer study drugs as per protocol
- Monitor adherence to study drugs
- Conduct adherence counselling when needed
- Collect blood samples etc as per schedule of events for each protocol
- Complete lab request forms and arrange for shipment/transfer to local labs for further processing
- Receive and follow-up on laboratory results, collate and compile for Clinician review.
