#### 1. The UnitAfrica Project

The UNITAFRICA project, led by Italian Universities (IUs) within the Italian University Network for Development Cooperation (CUCS), is a strategic initiative designed to promote collaborative training, research, and international academic cooperation with partner institutions across Africa. The project is funded by the NextGenerationEU through the National Recovery Plan (PNRR).

#### 2. Description of the visit programme

The University of Udine (Italy) offers two (2) PhD students (student mobility) and two (2) researchers (staff mobility) from partner African universities in the UnitAfrica project the opportunity to spend three months in its research laboratories, collaborating with its professors and engaging in joint research activities.

The purpose of these visits is to enhance the research capacity of scientists, helping them to foster linkages for further collaboration.

### 3. Requirements and Eligibility

Applicants must be a PhD student or a researcher from one of the African partner universities of the UnitAfrica Project (Annex 2).

Applicants' scientific field of research must be one those listed under section 2. Only applications within these fields will be considered.

Before submitting an application, candidates must:

- contact a University of Udine professor (internal supervisor) working in one of the identified target research areas (section 2),
- share their proposal with him/her and obtain his/her approval/signature (see Annex 1) AT LEAST 15 DAYS BEFORE THE APPLICATION SUBMISSION. The contact person listed in the table in section 2 can assist potential applicants in identifying the most suitable supervisor within each Department.

### 4. Application documents and application deadline

The application must:

- Be completed in English, signed by internal supervisor (section 3) and signed by the applicant;
- Include a copy of applicant's passport (only the page with personal details);
- Include a copy of the applicant's curriculum vitae;
- Include the full list of the applicant's scientific publications (do not enclose copies of the articles);
- Be sent to [sara.distefano@uniud.it](mailto:sara.distefano@uniud.it) and [amce@uniud.it](mailto:amce@uniud.it) within the application deadline.

Applications that do not meet these requirements will not be considered. The application deadline is September 30<sup>th</sup>, 2025.

### 5. Selection procedure and rankings

Applications that meet the above-mentioned parameters (see article 4) will be automatically selected until funds are exhausted.

The beneficiaries will be advised within 20 working days after the reception of the complete application.

The mobility could take place only if the beneficiary's institution has already signed or will sign an inter-institutional agreement with the University of Udine.

### 7. Period

The research can take place starting from a month before the selection to March 31<sup>st</sup>, 2026, with the specific period to be agreed upon with the professor at the University of Udine responsible for the selected research area.

Please, take into consideration that applications for the period 1<sup>st</sup> – 31<sup>st</sup> of August will be not possible due to the summer break holidays.

### 8. Miscellaneous

Each beneficiary will remain registered full-time at their home institution and will continue to pay tuition and other fees there. The beneficiary will be responsible for the following:

- finding accommodation in Udine. However, the University of Udine will assist beneficiaries in locating housing, if possible,
- covering all expenses incurred in connection with participation in the program,
- arranging their own VISA and residence permit (if required)
- securing their own medical insurance to cover any potential medical expenses.

### 9. Administrative Procedures Responsible
