The successful candidate will lecture in the discipline of Geological Science, which is based at Westville Campus. Duties include, but may not be restricted to, delivering the module HYDRGEOLOGY (GEOL321). Lectures for Hydrogeology cover fundamental concepts in hydrogeology including nature of groundwater and aquifers, principles of groundwater flow, well hydraulics, groundwater exploration, development & management, hydrochemistry and introduction to isotope hydrology, introduction to conceptual hydrogeological modelling. Practicals involve Darcy's experiment, estimation of aquifer parameters including pumping test data analysis, interpretation of hydrochemical and water isotope data and a day long hydrogeology field class. Details of the module content are available on request. S/he should have a good background in Hydrogeology.

The incumbent will report to the Academic Leader: Geological Science

Minimum Requirements:

- Master's degree in Geological Sciences or related field, with a preference in Hydrogeology and/or Engineering Geology.
- Relevant teaching experience in teaching at a tertiary institution.

The successful appointee will be required to fulfil their responsibilities to the teaching programme within these changes.
