The incumbents appointed will be expected to lecture or assist with lecturing COMP100 (Introduction to Computer Science). Ability to program in python is essential. Duties include, but may not be restricted to, preparing teaching material, delivering lectures and/or tutorials, overseeing student practical sessions, setting and marking assessments and/or exams, student consultation, timeously completing the required administrative documentation related to the module delivery, and attendance at relevant staff meetings. The candidate must have knowledge and experience in teaching COMP100.

The appointments will be effective from February 2026, and the duration of the appointment will be based on the academic needs of the school.

The incumbent will report to the Academic Leader: Computer Science.

Minimum requirements:

- An MSc degree in Computer Science, or a relevant field
- Experience in teaching at the tertiary level, including the use of online teaching platforms.
- Evidence of presentations at national or international conferences,
- Current research activity as evidenced by a publication in quality scientific journals.

The remuneration will be at the University standard rates of pay on a per lecture/tutorial/practical basis.
