Lectures will be allocated depending on the exact requirements of the School.

The incumbent will report to the Head of the Discipline of Physics.

- A PhD degree in the relevant discipline OR Master's degree in the relevant discipline, with evidence of submission of PhD for examination.
- Experience in teaching in a relevant field at a tertiary institution.
