The successful candidate will be appointed to lecture half (8 credits) of the first-year level Human Environments (GEOG110) module. Duties include but may not be restricted to delivering the practical component, setting and marking tests and exams and other duties assigned by the Line Manager.

The incumbent will report to the Academic Leader of the Geography Cluster.

Minimum Requirements:

- A PhD degree in the relevant discipline or Masters degree in Environmental Sciences or Environmental Management/MA degree in Geography (with an understanding of Human Environments), with evidence of submission of a PhD for examination.
- Experience in teaching in a relevant field at a tertiary institution.
- Evidence of presentations at national or international conferences.
- Current research activity as evidenced by a publication in quality scientific journals.

REMUNERATION: The remuneration package offered will be dependent on the qualifications of the successful applicant, in line with UKZN remuneration for ad hoc lecturer level. However, all practicals and assessments are delivered in the traditional contact mode. The successful appointee will be required to fulfil their responsibilities to the teaching programme within these changes.
