The successful candidate will lecture in the discipline of Geology, which is based at Westville Campus. Duties include, but may not be restricted to, delivering the modules Environmental Geology (GEOL313) and Introduction to Environmental Geology (GEOL222). The two modules will be taught concurrently where the class will comprise the second-year and third-year cohorts. Lectures for Environmental Geology cover fundamental concepts such as: Earth's internal and external processes and associated hazards, including mass wasting, flooding, earthquakes and volcanoes; Water resources, including groundwater and surface water resources, water quality and pollution; climate change; Mineral resources extraction and its impact on the environment, including acid mine drainage; Waste management, environmental pollution and pollution control, and environmental impact assessment. Practicals involve land use and engineering geology maps; identification and assessment of volcanic, seismic, mass movement and flood hazards; water balance and water resources evaluation; water quality analysis; waste disposal site selection. Details of the module content are available on request. S/he should have a good background in Hydrogeology.

- Experience in teaching in a relevant field at a tertiary institution.
