The successful candidate will be appointed to lecture half (8 credits) of the first-year level Human Environments (GEOG110) module. Duties include but may not be restricted to delivering the practical component, setting and marking tests and exams and other duties assigned by the Line Manager.

The incumbent will report to the Academic Leader of the Geography Discipline.

Minimum Requirements:

- MSc degree in Environmental Sciences or MSocSci degree in Geography & Environmental Management/MA degree in Geography, with an understanding of Human Environments.
- Experience in teaching in a relevant field at a tertiary institution.

REMUNERATION: The remuneration package offered will be dependent on the qualifications of the successful applicant, in line with UKZN remuneration for ad hoc lecturer level. Rates of pay will be per University fixed-term rates and official module (Handbook) approved hours for these academic duties.

The structure of this module may be adjusted and may include blended learning and remote teaching (70% contact and 30% online). However, all practicals and assessments are delivered in the traditional contact mode. The successful appointee will be required to fulfil their responsibilities to the teaching programme within these changes.
