The Graduate School of Business and Leadership (GSB&L) seeks to appoint a suitably qualified candidate to the position of Acting Head of Masters and Postgraduate (PG) Programmes.

The main purpose of this position is to implement the strategy related to the Master's and PG programmes within the School. This includes ensuring that these programmes remain industry-aligned, responsive to trends in executive education, and contribute meaningfully to leadership and management development across Africa. The role also involves providing input into strategic initiatives related to Master's and PG programmes. The Acting Head of Master's and PG Programmes will provide strategic leadership and academic direction for these programmes within the School.

The incumbent reports to the Director: Academic Programmes or Deputy Dean and operates within a distributed academic model, overseeing the design, delivery, and review of programmes delivered by academics based in disciplinary Schools across the University. The role requires strong academic leadership, collaboration, and governance oversight to ensure the quality, coherence and strategic alignment of postgraduate coursework and research components.

Minimum Requirements:

- Doctorate Degree in a relevant discipline and at least at Senior Lecturer level.
- Ten years' experience in teaching/lecturing/research.
- At least five of which must be in postgraduate teaching or developing junior staff.
- An excellent recent and continuing record of research and publications.
- Experience in the development/reform of teaching modules, or curricula.
- In addition to all the above, where applicable, registration with the appropriate regulatory body may be a minimum requirement.
- Show evidence of teaching excellence at postgraduate level.
- Have a sustained record of strategic leadership in academic practice and academic development.
- Ability to provide academic leadership in a range of appropriate contexts (e.g., learned societies, research grants, professional associations, academic networks).
